ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS AND RELEASE OF LIABILITY**

I understand that participation in zipline/archery activities involve significant risks which include, but are not limited to, falling or slipping, impacting objects or being impacted by objects, equipment malfunction, equipment misuse by me, other participants or employees, natural, mechanical and environmental conditions and risks, any of which may independently, or in combination with the participant's action, cause serious personal injury, death or property damage to the participant or others. I agree that I alone am responsible for my safety while participating in zipline/archery activities, and that Camp Emmanuel / Yellow Creek Lake Ministries, their employees, affiliates or any person or entity associated with them are not responsible for my safety. **I AGREE FREELY AND VOLUNTARILY TO ASSUME ALL RISKS**, including the risk of death, injury or damage to person or property associated with participation in zipline/archery activities. I agree to accept the conditions as they exist even though I may have chosen not to inspect the zipline/archery facilities as well as to accept and abide by the rules and regulations of the zipline/archery facility.

I hereby agree for myself, my heirs and for anyone on my behalf, to the fullest extent allowed by law, **to RELEASE, INDEMNIFY AND HOLD HARMLESS** Camp Emmanuel / Yellow Creek Lake Ministries, their owners, directors, officers, employees, agents, volunteers, representative, affiliates, successors and assigns from any and all responsibility and legal liability for any property damage, personal injury, damage or death which may result directly or indirectly from participation in zipline/archery activities, whether such injury or damage was foreseeable, including any claim regarding design or maintenance of the premises, design or condition of any equipment utilized while engaged in zipline/archery activities, or any other cause or claim arising from participation in zipline/archery activities, including any claims of breach of contract or other legal theory, including NEGLIGENCE. **I PROMISE TO NOT SUE, and to INDEMNIFY, HOLD HARMLESS AND DEFEND** Camp Emmanuel / Yellow Creek Lake Ministries for any claim of injury, damage or death which may occur from my participating in zipline/archery activities. NOTICE: BOTH Camps are at the SAME time. We will function at TWO SEPARATE camps – different sleeping quarters, different classes, different activities times. Together ONLY for meals and perhaps swimming time.

SENIOR CAMP JULY 7-13
For those just completing grades 7 - 12.
(NOTE: **MUST** be 13 by July 13.)

JUNIOR CAMP JULY 7-13
For those who are ages 9 - 12 years old.
(NOTE: **MUST** be 9 by July 13)

ALL Campers are to arrive Sunday between 4:00 and 5:00 pm. **ALL Campers** will leave at 10:30 a.m. SATURDAY.

CAMP PURPOSE

The primary purpose of Camp Emmanuel is: a) to strengthen the campers in their faith in the Lord Jesus Christ; b) to increase their knowledge of His word, the Bible; c) to encourage them to live faithfully for Jesus Christ -- by the leaders, counselors and other campers.

CAMP COST

Camp Emmanuel is a ministry of faith supported by those who believe in its purpose. Because of donations, campers attend **AT NO FINANCIAL CHARGE!** Each evening a free-will offering is accepted from the campers. Donations are also cheerfully and thankfully accepted from interested parents, friends and churches.

QUALIFIED CAMPERS

Camp Emmanuel accepts campers from the Participating Churches. These Participating Churches are listed below. The Pastor of the church must certify the camper is actively involved in their church or is coming as a guest.

The campers MUST meet the following requirements: 1) have attended church at least 6 of the 8 Sundays preceding camp; 2) know and recite the Roman's Road – topic title, verse "address," and the words of the verse; 3) complete and deliver the registration form to the Pastor on or before July 1.

CAMP BANK

ALL monies brought to Camp Emmanuel **MUST BE** placed in the camp bank. This is to safeguarding the camper's monies. The bank opens daily at store times and before the evening service. **HOW MUCH?** \$5 to \$20 for treats. \$10 for a Camp Emmanuel t-shirt. \$20 - \$30 is plenty! Plus any money they want to give as an offering. The remaining balance is refunded before the camper returns home.

4. CONFESS & BELIEVE IN THE LORD

Romans 10:9 If you confess with your mouth the Lord Jesus and believe in your heart that God has raised Him from the dead, you will be saved.

5. CALL ON THE LORD

Romans 10:13 For whoever calls on the name of the LORD shall be saved.

CAMP STANDARDS

ALL CAMPERS ARE EXPECTED TO:

- conform to Christian standards of conduct
- cooperate with the Camp leaders
- be modest in dress/appearance

- remain on camp grounds at all times
- not leave services without permission
- remain in cabin after curfew

DRESS CODE

BOYS

Daytime: jeans, slacks, (**NO SHORT SHORTS**), t-shirts or collared shirts (shirts **MUST** be worn at all times) – NO bare midriiffs.

Evening: Neat, slacks, jeans

Lake: MODEST swim trunks. (**NO BIKINIS**)

GIRLS

Daytime: jeans, slacks, (**NO SHORT SHORTS**), culottes, skirt and blouse, dress (**NO MINI SKIRTS**) – NO bare midriiffs.

Evening: Neat, slacks, jeans, skirt, dress

Lake: MODEST one-piece swimsuit. (**NO BIKINIS**)

SWIMMING

There will be swimming in the lake. A certified life-guard will be on duty during all swimming.

CAMP STORE

The store is open each afternoon and evening for the camper to purchase candy, gum, pop and other like items.

WHAT TO BRING

- Water bottle with name on it
- Bibles, notebooks, pens, pencils, sharpie, etc.
- Musical instrument, camera, sunglasses
- Sleeping bag, pillow, blankets, sheets, etc.
- Towels, washcloths, soap, toiletries, etc.
- Robe and swimwear (Modest one-piece)
- Athletic (tennis) shoes
- Wading or water shoes/"flip-flops"
- Spending money (up to \$25)
- NO Short Shorts, "Bike" shorts, or cut-off tops
- NO Rock, Booze, or Tobacco t-shirts
- NO CELL PHONES** (possession of a cell phone after registration is grounds for being sent home.)
- NO Electronic devices of any kind – including IPODS, MP3 players, iPads, Computers OR ANYTHING similar

SPECIAL NOTES

A Registered Nurse is on duty. **ALL** medications **MUST** be turned over to the Camp Nurse.

Please mark items for identification. Camp Emmanuel is not responsible for items lost by the camper.

To fully benefit from the Camp Emmanuel experience, it is expected the Camper will be in attendance for the entire week. If leaving the Camp is unavoidable, the parent or guardian must make the request to the Camp Dean.

The accompanying registration form **MUST BE** completed and signed by the camper AND the parent/guardian AND the Pastor of a Participating Church (see below) by June 24. A "hold harmless" agreement must also be signed for each camper. A camper without this completed pre-registration form **WILL NOT** be permitted to stay at Camp Emmanuel.

The standards, guidelines and rules of Camp Emmanuel are based on spiritual principles, convictions and experiences of the Camp leaders in order that ALL THE CAMPERS may have the best possible Christian Camp experience.

Background Check:

ALL counselors and teachers will have "passed" an official Background Check. Two reasons: a. safety of our campers; b. insurance regulations.

SPECIAL DIETARY NEEDS

If you have special needs, please BRING your own foods for the week. A refrigerator and microwave are available.

CONSEQUENCES OF NOT COOPERATING

If a camper (1) refuses to cooperate with the Camp leadership OR (2) displays an unacceptable attitude OR (3) breaks the rules OR (4) disregards the standards and guidelines of Camp Emmanuel, then without further warning nor "chances" the camper **MAY BE SENT HOME**. Camp Emmanuel MUST operate for the benefit of ALL campers and CANNOT allow one uncooperative camper to spoil camp for the rest. He/she WILL BE sent home.

DIRECTIONS:

In general: Yellow Creek Lake Camp sits in the country between Akron, Mentone, Silver Lake.

It is bounded by SR 25 on the north, SR 14 on the south, SR 15 on the east and SR 19 on the west.

Specifics:

1. On SR 19 between Akron & Mentone, turn EAST on 900 S. Go 4.25 miles. **Enter Camp on left** as meet 675 W turning South.
2. On SR 14 between Akron & Silver Lake, turn NORTH on 675 W. Go 2 miles. Enter Camp on right as meet 900 S turning West.
3. On SR 25 between Mentone & Warsaw, turn SOUTH on 700 W. Go 5 miles. Turn EAST on 900 S. Go 0.25 miles. **Enter Camp on left** as meet 675 W turning South.
